REASON FOR SALE: Sidney Sugars beet sugar plant began plant closure procedures on April 14, 2023. As a result of the plant closure, all surplus real estate and equipment will be sold via a Sealed Bid and Online Auction. Maas Companies is auctioning the main process facility, Parcel 1, with Parcel 2, via a Sealed Bid Auction. Parcel 1 is the majority of the process equipment, buildings and associated 325.47± acres of the main plant site. Parcel 2 consists of 104 acres of land. Parcels 4 & 5 will sell as a package. Parcel 4 consists of 30.529± acres of hunting/recreational land. Parcel 5 consists of 240 acres of irrigated tillable farmland along the Yellowstone River which is part of the Lower Yellowstone Irrigation Project. Parcels 4 & 5 and remaining surplus equipment will all sell piecemeal via an online auction.

PLANT SUMMARY: The facility has processed locally grown sugar beets into refined sugar and related agri-products since it was constructed in 1925. Sidney Sugars Incorporated acquired the facility in 2002 and operated it through the 2023 processing campaign. At its peak, its 300 employees processed sugar beets grown on approximately 45,000 acres in Eastern Montana. The plant is a perfect candidate to be repurposed for another industry. The plant is centrally located in Sidney, along the BNSF railroad with several thousand feet of owned rail on Parcel 1. The main rail loading building is climate controlled and has rail scales.
